Highfield Level 2 Award for Working as a Security Officer within the Private Security (RQF)

Under the Private Security Industry Act 2001, all security officers must hold a licence to practice, issued by the Security Industry Authority (SIA). To work as a security officer you need to apply for a SIA licence. You cannot get your SIA licence without first attending this training course and gaining the Security Officer qualification. Once you have your licence you can start earning and have an exciting career in the security industry earning rates of up to £8-10 per hr, and salaries of £19k+ year.

Qualification Structure

This qualification consists of three units, which learners must complete successfully in order to achieve the qualification, they are;

- Unit 1 Working within the Private Security Industry
- Unit 2 Working as a Security Officer within the Private Security Industry
- Unit 3 Conflict Management within the Private Security Industry

Duration

Courses are delivered over four days. Plus distance learning for elements of Unit 1 before attending this training.

How will I be assessed?

Multiple-choice question exams which are externally marked by the awarding body. Practical assessments on the course for Safe Searching, Use of a Radio, and Conflict Management.

NEW Entry Requirements from 1st April 2020

You must hold a Level 3 Emergency First Aid at Work certificate (or above) which has at least 12 months to expire prior to starting this course. Evidence will be required upon enrolment of your current first aid certificate.

We offer evening classes for one night a month, 6pm to 10pm. Or you can attend one of our day courses which we run every month to get this qualification before you attend your course.

Security operatives are likely, in the course of their work, to be required to make calls to the emergency services, and communicate clearly to resolve conflict. It is therefore essential that security operatives are able to communicate clearly. All learners are therefore required to demonstrate a good grasp of the English language, as assessments are only available in this language. This may involve completing a short assessment prior to enrolment. Minimum age of 18.



Photo and ID Requirements

You will need to bring ID with you to be able to sit the exams. If you have a current Passport and a photo driving licence these will be ideal. Please refer to the ID requirements sheet which you will be sent with your joining instructions to make sure you will have the correct and sufficient amount of ID to be able to do the course and sit the exams.

Joining Instructions

On receipt of your completed enrolment form and course fees, you will receive detailed and informative instructions. This will include information on the distance learning unit you will need to complete prior to attendance.

Cancellations

In the unfortunate event you have to cancel your course a cancellation fee may apply. *Cancellation fees are as follows;*
